#### Introduction

#### Information We Collect

#### Personal Data

#### Non-Personal Data

- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which Personal Data about our Website users is among the assets transferred.
- To fulfill the purpose for which you provide it.
- For any other purposes disclosed by us when you provide it or for any other purpose with your consent.
- We may also release your Personal Data to comply with any court order, law, or legal process, including, without limitation, to respond to any government or regulatory request.

- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Indy Chamber, LLC, our Website users, or others.
